



Planter's Row Pool Rules

Access card is required to enter the pool or tennis courts. If your card does not open the gate then you will not be granted access. Contact Amie Orr at Goldsmith Property Management at 672-1263 or email HOAadmin@goldsmithpm.com. Gate Attendants will monitor access to the pool area on a regular basis.

1. NO ONE WHO HAS A COMMUNICABLE INFECTION OR DISEASE SHALL ENTER THE POOL.
2. NO PETS ARE ALLOWED IN THE POOL AREA.
3. DURING ELECTRICAL STORMS, THE POOL MUST BE EVACUATED, AS DIRECTED BY THE LIFEGUARD STAFF.
4. THERE WILL BE NO RUNNING, PUSHING OR ANY TYPE OF ROUGHNESS IN THE POOL OR CABANA AREA.
5. THERE WILL BE NO PROFANITY IN THE POOL OR CABANA AREA.
6. THERE WILL BE NO SMOKING IN THE POOL OR CABANA AREA. A SMOKING AREA HAS BEEN DESIGNATED OUTSIDE THE CABANA NEAR THE BIKE RACK.
7. ACCEPTABILITY OF OBJECTS FOR PLAY IN THE POOL SHALL BE DETERMINED BY THE LIFEGUARD STAFF OR RECREATIONAL COMMITTEE CHAIR PERSON.
 1. A FLOAT, RAFT OR BOAT FLOAT DESIGNED TO **HOLD MORE THAN A SINGLE PERSON** IS NOT PERMISSIBLE.
 2. REGULAR FOOTBALLS, GOLF BALLS, ETC ARE NOT PERMISSIBLE.
8. NO GLASS OR DANGEROUS OBJECTS SHALL BE BROUGHT INTO THE POOL OR CABANA AREA.
9. ALCOHOLIC BEVERAGES SHOULD BE OUT OF PUBLIC VIEW CONCEALED BY A KOOZIE.
10. NO CHILDREN UNDER THE AGE OF 18 ARE ALLOWED IN THE POOL DURING THE MANDATORY 10 MINUTE ADULT SWIM AT 50 MINUTES PAST THE HOUR. EXCEPTION TO THIS RULE; CHILDREN UNDER THE AGE OF 3 CAN BE IN THE POOL WHILE BEING HELD BY AN ADULT OR PARENT.
11. NO CHILD, WHO IS NOT TOILET TRAINED, WILL BE ALLOWED TO SWIM IN EITHER POOL WITHOUT SWIM PANTS OR SWIM DIAPERS.
12. NO DECORATIONS ARE ALLOWED THAT WILL CAUSE DAMAGE TO THE POOL PROPERTY OR FURNISHINGS. BALLOONS SHOULD BE LIMITED TO THE CABANA AREA.
13. ANYONE ENTERING THE POOL MUST HAVE PROPER AND ACCEPTABLE SWIMWEAR. NO CUT OFF SHORTS.
14. MUSIC SHOULD BE PLAYED AT AN ACCEPTABLE VOLUME. BE COURTEOUS, NO LOUD MUSIC.
15. NO RIDING SKATEBOARDS, BIKES OR SCOOTERS IN THE CABANA OR ON POOL DECK.

- Pool Rules are established by the Planter's Row Community Recreational Committee. Upstate Pool Management Company monitors and enforces these rules as directed and supported by the committee and board of directors.
- All persons using the pool do so at their own risk. Planter's Row and Upstate Pool Management assume no responsibility for injury or damages resulting from use.
- Pool use is a "Privilege" and not a "Right" of being a member of the Planter's Row Community. Pool rules are established for the safety of all community members and create an environment of family fun. Any person not following the Pool rules will be asked to leave the Pool and Cabana area.
